For the purpose of buying hunting and fishing licenses, residency is determined by the issuance of your driver's license. Residents with non-driver's ID card and those with no ID must submit proofs of residency. See the revised residency flyer.

Non-Driver ID cards will be checked for valid driver's license in other states.

REQUIRED DOCUMENTS - ALL DOCUMENTS MUST BE DATED WITHIN PAST YEAR.

Applications with the current SSA paperwork stating 'SSI', 'SSDI' or 'currently receiving disability benefits' can be issued. Visit your local SSA office or call 1-800-772-1213.
